Public Notice:
Proposed Changes to Clark County Code
RE: Title 22, Chapter 22.02

Please take notice that a rule is being proposed by the Clark County Board of County Commissioners as follows:

An ordinance to amend Title 22, Chapter 22.02 of the Clark County Code sections 22.02.035, 22.02.055, 22.02.065, 22.02.190, 22.02.235, 22.02.250, and 22.02.360:

- 22.02.035 – Definitions - added**
- 22.02.055 – Maintenance - modified**
- 22.02.065 – Temporary Use Buildings or Structures - modified**
- 22.02.190 – Building Permit Exemptions - modified**
- 22.02.235 – Information on Plans and Specifications - modified**
- 22.02.250 – Contractor’s Responsibilities – modified**
- 22.02.360 – Work with-out a Permit - modified**

Prior to the adoption of the proposed rule, the Clark County Board of County Commissioners is required by NRS 237.080 to make a concerted effort to determine whether the proposed rule will impose a direct and significant economic burden upon a business or directly restrict the formation, operation or expansion of a business. Due to this, trade associations, owners and officers of businesses which are likely to be affected by this proposed rule, and any other interested persons are required to be notified and provided an opportunity to submit comments, data, or arguments to the County regarding whether the proposed rule will:

- a) Impose a direct and significant economic burden upon a business; or
- b) Directly restrict the formation, operation or expansion of a business.

Comments must be submitted no later than **5:00 p.m. on August 11, 2020** as follows:
